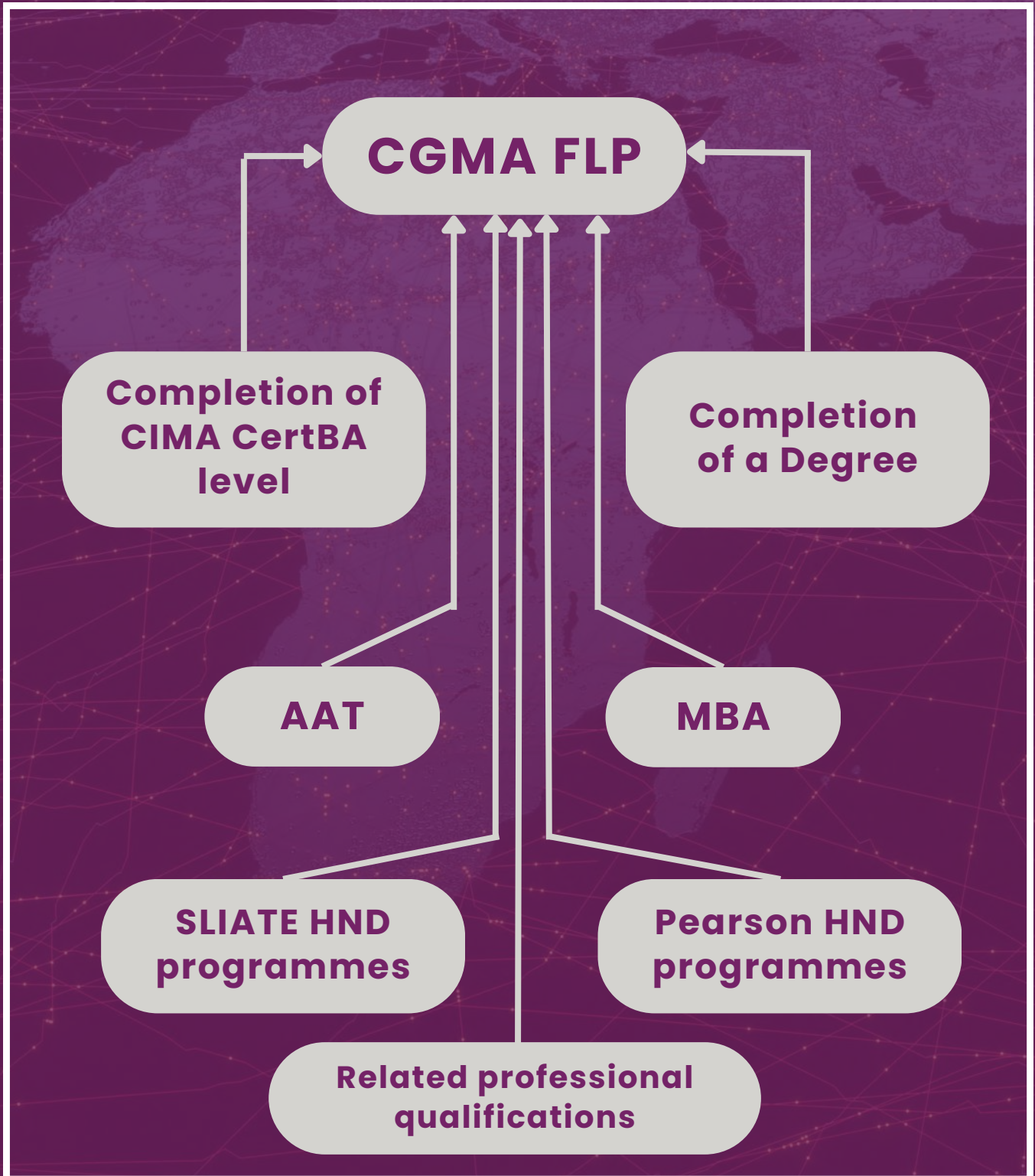

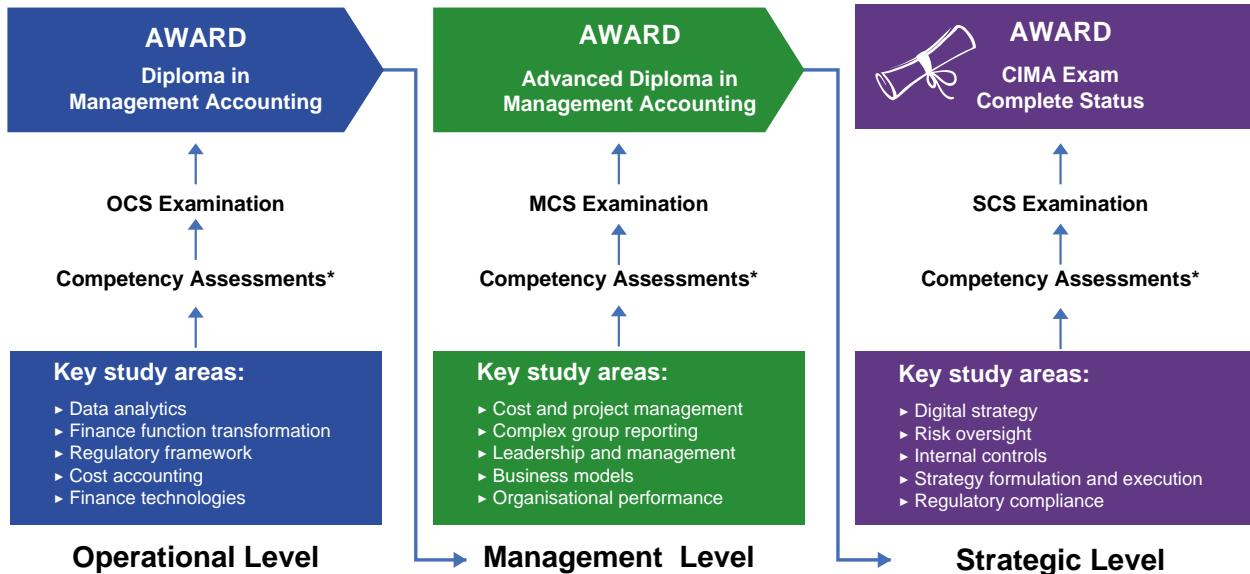

Award	After completing either route, learners become CIMA members and are awarded the use of CIMA designatory letters (ACMA or FCMA), as well as the CGMA designation.
